The joining by shareholders for this meeting was open 30 minutes prior to the commencement of the meeting and will remain open for 15 minutes after the conclusion of the meeting. And I am pleased to report that, for the financial year 24-25, our revenue from operations reached ₹230 crore, and reflecting a robust 30% year-to-year growth. Our net profit stood at 22 plus crore. We continue to expand our reach across Uttar Pradesh with the launch of new diagnostic centers in Varanasi and Lakhinpur. We have entered Rajasthan with a new center in Jaipur, offering comprehensive diagnostic services under one roof. In Lucknow, we inaugurated our fifth diagnostic center at Ashiyana, further reinforcing our leadership in the city. And in Ayodhya, we opened our second center, bringing advanced diagnostic care closer to the

**Dr. Amar Singh:** Okay ma'am. Actually, if you go through our business in the past, our basically business was based on the referral practice. We were getting the references from the doctors, that was our main business. And besides this, we were doing corporate business also through insurance, public youth sector units, banks, private sector units. This was our corporate business, and then in the later stages, we started with government business also. We are doing NHM in Uttarakhand and we are doing free diagnostic services to whole the population of Uttarakhand, and we are in the process of other states

also now. And we are having one CT scan installed in Gorakhpur Medical College. These three segments we were doing in the past. But what we have done now we have started focusing on online business as well as franchise business also, just to keep our profitability and business in line. And that will definitely add in future a great part of this business. And as far as pharmacy is concerned, we are already doing B2C business, B2B business and B2G. We have our more than 50 retail units all over UP, Uttarakhand, and in other states. And in B2B business we are supplying the medicines to hospitals and B2G we are supplying the medicines to few governments' organization like HAL, etc. And now we are going for supplying to different government organizations also, and that is also in the process. All these things will definitely help us maintain the same type of profitability in the future, and rather better than past. It's possible.
