The project aims to strengthen diagnostic infrastructure within a government hospital and improve access to advanced imaging services for both in-patients and out-patients. Under the said PPP arrangement, the Company shall establish and operate a state-of-the-art radiology diagnostic centre equipped with the following facilities:

- 800 mA High Frequency X-Ray
- USG & Colour Doppler
- 128 Slice CT sScan
- 3 Tesla MRI
